THE EIGHTEENTH ANNUAL REPORT  
FOR THE YEAR ENDED 31ST DECEMBER, 1953

*Proceedings at the Annual General Meeting, 1953*

THE EIGHTH ANNUAL GENERAL MEETING of the Association, being the seventeenth since the opening of the Museum, was held on Thursday, 12th March, 1953, at 2.30 p.m., at the Museum of Archaeology, Downing Street.

The Patron, Lord Fairhaven, presided, supported by the Hon. Secretary, Alderman F. J. Priest, the Hon. Treasurer, the Reverend R. Corboy, and about 25 members.

The Hon. Secretary read the notice convening the meeting and the minutes of the previous Annual General Meeting were read, confirmed and signed.

A number of apologies for non-attendance were received and sympathy was expressed at the indisposition of the President, Mr. E. S. Peck, as the result of an accident.

The Chairman referred to the 92nd birthday of Mrs. Keynes that had recently been celebrated and it was unanimously resolved that a letter of congratulation be sent to her by the Hon. Secretary.

The 17th Annual Report, that had been circulated, was adopted upon the proposition of the Chairman, who expressed satisfaction at the continued improvement in attendances at the Museum. This he attributed to the series of interesting special exhibitions arranged by the Resident Curator, Miss E. M. Porter. He stressed the need of attracting new members and looked forward hopefully to the day when the Abbey House would be available for use as a Folk Museum.

The Hon. Treasurer presented the statement of accounts for the year ending 31st December, 1952. He said that following an interview with the City Treasurer it had been agreed that £90 5s. 1d. be refunded to the City. This sum was the balance of £77 11s. 3d shown in the 1952 balance sheet and the balance of £12 13s. 10d. which remained in 1951. The ruling of the City Corporation in connection with their greatly appreciated grant to the Museum was that all the revenues of the Museum, including the rents from Abbey House which had previously been kept separate, were to be included in the Museum's income.

The accounts were adopted on the proposition of Mr. J. Saltmarsh seconded by Councillor Mrs. Henn.

The officers were re-elected *en bloc*, a vacancy among the Vice-Presidents being left for the Executive Committee to fill. The two vacancies among the elected members were filled by the election of Mrs. Blackman and Miss M. Lyon of Homerton College.



The Auditor, Mr. R. Chater Blows, was re-appointed at the same annual remuneration of £5 5s. 0d.

At the conclusion of the meeting an interesting and entertaining lecture was given on "Assault and Battery in Country Life" by Mr. L. F. Newman, M.A., F.S.A., F.R.I.C., who was subsequently thanked by the Chairman on behalf of all present who included a number of visitors.

### *The Year in Retrospect*

The year that has just ended had no outstanding event to record. Rather could it be described as one of quiet development. Some redecoration of the rooms at the White Horse Inn has been carried out and the imposing group of statuary in the yard of the Museum immediately catch the eye of visitors and passers-by in Castle Street.

It consists of four pillars from the demolished Fountain Head that stood on Market Hill from 1855 to 1953. The Resident Curator has gone to considerable trouble in getting some historical facts about the local worthies depicted.

Always anxious to promote interest in the activities of the Museum, the President and Mrs. E. Saville Peck gave a sherry party at the end of October that was attended by between 40 and 50 guests, who showed keen interest in the various exhibits. Mrs. J. N. Keynes, at the age of 92, being among those present, visited the special exhibition of recent acquisitions on the first floor.

The Museum has lost three good friends, in the passing during the year of Mr. W. Brereton, Miss Alice Spalding and Mr. E. A. B. Barnard, a Vice-President at the time of his death.

At the Abbey House, routine repairs, always necessary in a building of this age and character, have been carried out. The biggest item was replacing some floor boards in No. 2 at a cost of £16. Here we were much indebted to Mr. H. C. Hughes for a careful survey of the woodwork generally.

It is to be hoped that some shrubs planted in the front garden of Abbey House will make progress during the coming year and thus enhance the appearance of a piece of ground that has had considerable trouble and expense devoted to it over the last two years.

### NOTES ON THE FIGURES FROM THE CONDUIT HEAD

#### *Sir John de Cambridge*

Probably a native of Cambridge; his daughter, Isabel, was a nun at St. Radegund's. He was M.P. for the county on several occasions between 1320 and 1326 and was knighted in 1328-29. In 1331 he was raised to the Bench of Common Pleas and in the same year was Seneschal to the Abbot of St. Albans.



He owned a good deal of property in Cambridge and by his will left much of it for the benefit of the Gild of St. Mary, of which he was a member. His Stone House in Findsilver (later Foul, now Trinity Lane) passed to Corpus Christi College, and soon afterwards to Gonville Hall. It afterwards formed part of the Gonville Court of Caius College, where it survived until the middle of the eighteenth century.

#### *Sir John Cheke*

Son of Peter Cheke, an Esquire Bedell of the University, John was born in Petty Cury in 1514. He was elected a Fellow of St. John's and became the first Regius Professor of Greek at Cambridge as well as Provost of King's College, Public Orator and Tutor to Edward VI. With his great friend, Sir Thomas Smith, and his pupil, Roger Ascham, he urged the reformed pronunciation of Greek, which evoked a condemnatory decree from Bishop Gardiner, Chancellor of the University. On the accession of Queen Mary, Cheke went abroad but was seized and imprisoned in the Tower for his Protestant views. On being reconciled to the Roman Catholic Church he was released until his death in 1557.

#### *Thomas Thirleby*

Born in Cambridge and educated at Trinity Hall he became a Doctor of Law. He entered the service of Archbishop Cranmer and was sent by Henry VIII to several embassies abroad. He became Archdeacon of Ely and Dean of the Chapel Royal and in 1540 signed the decree against the validity of the King's marriage with Anne of Cleves. In 1540 the King created the Abbey of Westminster a bishopric and Thirleby became the first and only Bishop of Westminster. In 1550 he became Bishop of Norwich and in 1554 Bishop of Ely of which latter office he was deprived in 1559 for refusing to take the Oath of Supremacy. He was imprisoned in the Tower but was soon removed to the custody of Archbishop Parker at Lambeth Palace where he died in 1570.

#### *Godfrey Goldsborough*

He was born in Cambridge, was educated at Trinity College, of which he became a Fellow, and became Archdeacon and later Prebendary of Worcester. In 1598 he was consecrated Bishop of Gloucester. At his death in 1604 he left 100 marks to Trinity College.

#### *Thomas Cecil, Earl of Exeter*

Born in Great St. Mary's parish in 1542, the only son of William Cecil, first Lord Burghley. He was admitted M.A. in 1571. He was for a time M.P. for Stamford and Sheriff of Northants. He fought in the Low Countries and in 1565 was made Governor of Brill. In 1588, he served with the Fleet which conquered the Armada. On his father's death in 1598 he



succeeded to the title of Lord Burghley. His charities included the foundation of an almshouse at Liddington and an annuity to Clare Hall, Cambridge, for the endowment of 3 Fellows and 8 Scholars. He died in 1622-23 and was buried in Westminster Abbey.

#### *Orlando Gibbons*

Orlando was born in 1584, son of William Gibbons who in 1567 was appointed leader of the Town Waits. Orlando had several brothers and sisters born and baptised in Cambridge and for long it was assumed that he himself was born in the town. But the City of Oxford Records show that William Gibbons had settled in Oxford by 1583 when he leased the former Augustinian Friary there. Orlando, who was a chorister in King's College choir, subsequently became a Bachelor of Music of Cambridge University and in 1602 was created Doctor of Music at Oxford. In 1604 he was appointed Organist of the Chapel Royal. He died of smallpox at Canterbury in 1625 and was buried in the Cathedral there. His musical works include five part madrigals, hymn tunes and anthems and, in partnership with William Byrd and Dr. John Bull, a book of virginal music called "Parthenia."

#### *Thomas Hobson*

Born c. 1544, probably at Buntingford, Thomas Hobson lived in Cambridge from 1561 and carried on his father's business as carrier. A wealthy man, Hobson owned several manors and estates, including the site of Anglesey Priory, but devoted much of his wealth to the good of his fellow citizens. He gave a Bible to St. Bene't's Church, conveyed to trustees on behalf of the Town and University, the site of the Spinning House or Hobson's Workhouse, and by will left money to the poor of several Cambs. villages and towards the maintenance of the Conduit. He died in 1630 during an outbreak of plague which had prevented him from continuing his usual journeys to London.

#### *Jeremy Taylor*

Born c. 1613, probably at the Wrestlers' Inn, Petty Cury, Jeremy Taylor was educated at the Perse School and Caius College, of which he was elected Fellow. His talents as a preacher attracted the attention of Archbishop Laud who made him his Chaplain. From 1637 to 1642 Taylor was Rector of Uppingham, then retired to Wales and devoted himself to writing his "Holy Living and Dying," "The Golden Grove" and other works. Certain passages in the latter work brought him imprisonment for a short period. On his release and return to London he was again committed to the Tower for allowing a print of Christ at Prayer, which offended Puritan susceptibilities, to be inserted in his "Collection of Offices." Released, he went to Ireland and in 1660 became Bishop of Down and Connor. He died in 1667 and was buried in Dromore Cathedral.



## HON. TREASURER'S REPORT

I beg leave first to report that we have lived just within the means at our disposal. In the Income and Expenditure Account, where the Income consists of our rents and the subscriptions of friends, there is a deficit of £456 9s. 7d. The subscriptions were less this last year by £156 12s. 4d. owing to the termination of generous covenanted donations. To meet the deficit therefore, we have to have recourse to the promised grant (up to £500) of the City Corporation; in the course of the year we received from this an advance of £200, and now have to request the further £256 9s. 7d. to make up our deficit. The Appropriation Account printed at the foot of the Income and Expenditure Account shows our position with reference to the City grant. I repeat, therefore, that we are about £44 within our means.

On the expenditure side there may be seen the increases that one expects nowadays, although the figure is almost identical with that of the previous year; less has been spent on repairs: 1952, £280 17s. 10d.; 1953, £206 9s. 7d. Of the latter there has been £69 9s. 4d. spent on Abbey House.

Again I would thank those who have subscribed to the Museum and who in so doing have expressed so cordial an encouragement to its work.

## RESIDENT CURATOR'S REPORT

1953 brought a very slight increase in the number of visitors to the Museum but local schools have maintained their attendances and a feature of the past year has been the increased number of school visits from outside the County and of school children who have come to the Museum on their own during their holidays to make notes and drawings. Visits have also been paid by the British Council, the Newcomen Society, the W.E.A., Townswomen's Guilds and other organisations. On several occasions the Museum has been opened in the evenings to allow Youth Clubs, etc., to visit it.

The Exhibitions held during the year were: "Schooldays"; "Local Shops and Inns" and "Recent Acquisitions." The Resident Curator is grateful to the many local tradespeople who helped by lending photographs for the Shops and Inns Exhibition and, in some cases, for allowing copies to be taken.

Several loan exhibitions were made to local schools and the Resident Curator has given a large number of talks in Cambridge and surrounding villages and in Bedfordshire.

The Children's Room has been redecorated and a wall case installed. The case is of great use as it means that the dolls are now protected from dust and from being handled by small visitors. Another improvement to the appearance of the Museum has been the painting of the Bar and lower hall.



The Resident Curator is grateful to Dr. Bushnell who on more than one occasion allowed objects to be cleaned and treated at the Museum of Archaeology. Acknowledgment is also due to the Editor and Staff of the "Cambridge Daily News," particularly Miss Maloney, for their help in publicising the work of the Museum.

When, on account of its unsafe condition, the Conduit Head on Market Hill was demolished in August, 1953, the City Council generously allowed the four corners of the structure, with the eight figures of local celebrities, to be placed on loan in the Museum. The figures have now been installed in the Museum yard and short biographical notes on them appear elsewhere in this Report. A plaque giving their names is being prepared to be set up near the statues.

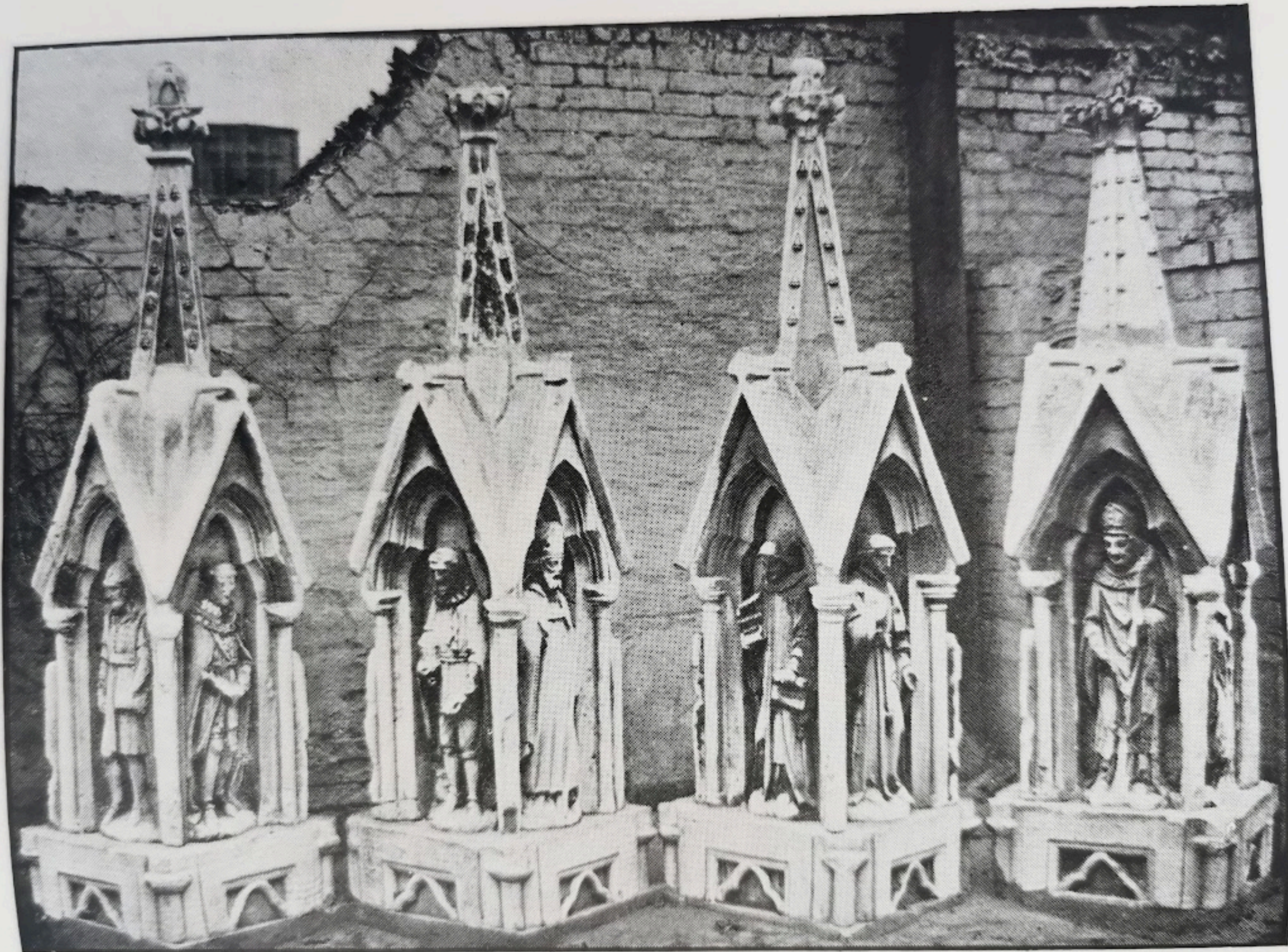
