## APPEAL for Funds for Church Extension in a new district.

In appealing for aid towards the work of the above Parish, may we first remind you of

### What Has BEEN Done.

#### Past efforts.

About **£4,000** has been **raised and expended** on sites and the building of a Mission Room, School, and the first section of the Permanent Church—the last **£1,000**, appealed for in 1896, having been raised chiefly in the district.

In addition, an **Endowment of £56** has been obtained from the Ecclesiastical Commissioners and the Governors of Queen Anne's Bounty, in return for a capital sum subscribed of **£930**.

The time has now come when further steps must be taken to provide for the spiritual needs of the rapidly growing Parish of S. John's, Cherryhinton, the population of which is now 2,000, having doubled in the last decade, and which, at the present rate of progress, will be 4,000 at the next census.

#### Church £5,000.

### What Has TO BE Done.

**The Church** as it stands at present is **unfinished**, consisting only of the Chancel and two bays of the Nave. The cost of completing the Church, with the requisite Vestries, &c., is estimated to be **£5,000**.

#### Vicarage £1,700.

It is also necessary that a **Vicarage** be provided, and this appears to be the most pressing of all the requirements of the parish. The Committee have availed themselves of an opportunity of purchasing for **£1,500** a most suitable Freehold house, near the Church, which has been approved by the Ecclesiastical Commissioners for a Vicarage House, subject to certain alterations and the making of a road, which additional expenditure is estimated to increase the cost to **£1,700**, and it is hoped that **when further donations amount to £700**, the balance will be met by a grant from the Ecclesiastical Commissioners.

#### Endowment £2,000.

The present endowment is **£56** a year, and it is obviously desirable that this be augmented. For the present it is hoped that **£2,000** may be raised, to increase the annual endowment to **£116**, further augmentation being made in future years.
